Call to Order: The motion for the approval of the antitrust review and the minutes of the previous committee meeting held were approved at 10:30 A.M.

- I. Human Trafficking Policy Discussion Hailey Betham, TCA Staff
 - Hailey Betham, Manager of Government Affairs shared the drafted Human Trafficking Policy. A motion was made for a six-month extension so more members of the Regulatory Policy committee can review this policy.
- II. Summary of Comments Filed David Heller, TCA Staff
 - Senior VP of Safety and Government Affairs, David Heller, shared the submitted comments that TCA has published since annual convention to the committee. TCA has made comments regarding DOJ Marijuana Reclassification, CDL Testing Flexibility and Leasing Agreements.

- III. Regulatory Update David Heller, TCA Staff
 - During a regulatory update, Senior VP of Safety and Government Affairs, David Heller, shared the following updates.
 - The Speed Limiters Supplemental Notice of Proposed Rulemaking (SNPRM) is projected for release in May 2025. However, any rule regarding speed limiters could be impacted by the DRIVE Act.
 - There is new data showing that drivers lose an average of \$7,105 in wages annually due to various industry issues. Additionally, Heller emphasized the need for the Senate to reflect the same \$200 million language in the House THUD bill to ensure funding for truck parking initiatives.
 - The FMCSA is proposing a new Safety Fitness Determination process, but it won't have an immediate impact on carriers, as 646,777 carriers have yet to receive their standings.
 - Regarding drug testing regulations, Heller mentioned that Oral Fluid Testing, which took effect on June 1, 2023, was rescinded due to a lack of certified laboratories and will not be entered through the clearinghouse. Meanwhile, Hair Testing has been residing at the OBM since March 31, 2022, with a rule yet to be finalized. A SNPRM on this issue is expected to be released in October 2024.
